- 1 C.Note/shipper charges will be Rs. 6-00 Per shipper plus GST @ 18%.
- 2 PROPREMIUM/Priority C-Note/shipper charges will be Rs 105-00 including GST, and Normal Tariff to the shipment according to weight.
- 3 Goods & Service Tax @ 18% : Applicable as per the Govt of india notification.
- 4 Fuel Surcharges will be @ 20% on the total bill amount. Non dox handing charge above 5 kg parcel Rs. 3-00 per parcel.
- 5 Delivery charges will be Rs. 3-00 up to one kg or part thereof. Above 5 kg rs. 2.50 per kg Please note, there should be proper shipment updation on internet in our software (TTS) is mandatory.
- 6 Plz. Advise client to **INSURED Shipment by himself only through Transit Insurance but if he insist then the Insurance ch.** will be 2% of the value of Parcel/Contents out of which 1% will be kept by the agency & 1% will be paid to us provided value mention & Prior intimation to us while booking with insurance charges paid to share the loss 50% by each party i.e the Franchisee and PCNL/HOT equally. No insurance will be entertained if value is not mentioned both on C-notes/shipper as well as on manifest/booking sheet.
- 7 Cheque dishonour charges will be Rs. 1000-00. There will volumetric weight charges for outsized bulky parcels with weighing formula as L x W x H divided by 5000.
- 8 Non-dox/Parcels GSTIN bill (e-way bill) should be given by the client/agency/booking office alongwith the Parcel And to be attached properly with the parcel without it parcel will not be forwarded.
- 9 **Following Items are restricted in Couries & Cargo services :-**
Sealed Passport or Cash, Gold, Silver, Precious Metals, Jewellery Articles, Precious and semi Precious Stones, Antiques, Ammunition, Fire Arms, Weapons, Liquids, Chemicals, Drugs, Banned Skin, hides, Letter with Post Box No., Articles for Cantt Area or A.P.O, Bearer D.D/Cheques, Unendorsed share Certificates, Live Stocks,Liquor, Narcotics etc.
- 10 Load has to be Connected to us by the agency/Franchisee by their own cost up to our office. Bill will be raised once in a month and payment realisation within seven days of bill date..
- 11 **International Shipment** - International shipment charges will be on Cash and carry basis after the rate confirmation from thePCNL/HOT office.
- 12 **Credit limit 30 days, After 30 days C.Note will be stopped & Load will be taken cash & carry basis for a week, after that load will also be stopped.**
